This form was prepared for the Project of location, documentation and preservation of Jewish heritage sites of former Jewish residents and their descendants, of Bukovina, Transnistria (in Ukraine, between the rivers Dniester and Bug) and several sites in Bessarabia (now in the Republic of Moldova), on the deportation route from Bukovina to Transnistria of Bukovina Jews by the Romanian occupiers, in 1941-1944.

It addresses Jewish cemeteries and Holocaust mass graves, Holocaust memorials and related sites such as concentration camps, ghettos and mass execution sites.

Jewish Bukovina Heritage Sites – Site Survey Questionnaire

The information that will be collected in these surveys will be stored in the project's website (Temporarily at <u>http://eylonconsulting.com/bukovina/</u>) and made available to whoever is searching for Jewish heritage information.

Conducting the Survey

This survey is conducted in order to collect the most recent and updated information about the Jewish Heritage Sites in the applicable territory. This information will be used for two main purposes:

1. To preserve it and make it available to whoever wants to learn about it. This will be done by storing it in a database and presenting it through a website that

allows searching by many parameters (so you can use what you know to get all that is there about that site and others).

2. To serve as a basis for restoration of heritage sites that needs it.

The project team has collected a set of heritage sites and the collected information is pre-loaded into the website (Temporarily at <u>http://eylonconsulting.com/bukovina/</u>).

The project team has published a call for volunteers to conduct the surveys. Volunteers can select the site(s) they want to survey and once approved by the **project team survey coordinator**, the site will be assigned to them.

We expect you to fill the information while on site, after looking at various sources and entering some generic information that does not require being on site. However - for certain information you must be on site.

To fill the survey, the project team has created a **Mobile Application tool** (Built using **Gazpacho from Netalizer Ltd**. that has donated the licenses for this purpose; **Thanks Netalizer**!),

This tool has the survey questionnaire built in and allows to enter the information online - even when you don't have cellular coverage. When pre-defined selection options are expected - they are built into the application and allow you to easily select/fill it. The information you enter is automatically transmitted (when you have coverage) and after review by the project team, will be updated into the data-base and become available in the website.

After being approved for a site(s) the volunteer will have a kick-off call with the project team representative, get a user ID and a password + training and will be ready for his mission.

Please notify the project team (<u>baruch@eylonconsulting.com</u>) upon completion of the survey so it can be entered into the project data-base and made available to people who may want to know it. Please don't hesitate to contact us through same address, with any question you may have.

- 1. Please **answer as many of the questions as possible**. It is understood that not every question is applicable to each site (especially the survey is mainly tailored for burial sites and we know that other site types exist and are different). If a question is not applicable please answer n/a.
- 2. Please feel free to provide **additional information and recommendations** about the site, its history and its condition if this information is available.
- 3. You may want to include several (5-8) **pictures** of the site and include them in the report. The tool allows it.



- 4. You may want to print the questionnaire prior to getting on site. You can fill parts on paper and then enter into the app.
- 5. If **several heritage sites exist** in the village/city, please fill a form for each site.


